## Apa itu CRGP

## Manfaat CRGP

- *Understand the relationship of corporate governance and risk management, in concept and practices, and how to implement it effectively, as to become adequate accountability embodiment for company's organ bodies in in the level of directors, board of commissioners, committees within the board of commissioners and shareholders' representatives.*
- *Understand the basic of risk management from the point of view of company's organ bodies in the level of directors, board of commissioners, committees within the board of commissioners and shareholders' representatives*
- *Understand several frameworks of "enterprise risk management" which are widely known (examples COSO and ISO 31000), from the point of view of the control holder or decision maker, at the level of directors, board of commissioners, committees within board of commissioners and shareholders' representatives*
